Attention All Dealers

Please take a moment to read the very important notice below from the Florida Division of Motor Vehicles, dated July 31, 2008. The DMV has decided that effective September 1, 2008 they will stop printing most of their forms for distribution to Florida Tax Collectors and Commercial Dealers. The DMV forms are and will be available to you electronically through website download.

The forms required to be printed on secure paper, as well as the eight (8) forms listed below will continue to be issued to you as hardcopy by the DHSMV through the Tax Collectors Office.

The office of the Seminole County Tax Collector has a small inventory of current paper forms that we anticipate will be available until September 15th. Once this supply is consumed, the DMV forms will only be available for hardcopy printing from our website (www.seminoletax.org), or the Division of Motor Vehicle's website (<http://www.flhsmv.gov/html/forms.html>). If a dealership is unable to download certain DMV forms, this office is willing to print a very small supply of the ones you need, but you will be responsible for making your own additional copies in the future.

SUBJECT: Ordering of Departmental Forms

In order to implement some cost savings measures due to budget reductions and continue excellent customer service, the Division of Motor Vehicles is making some changes to the ordering of forms.

Beginning September 1, 2008, you will access most forms on the Division's Intranet/Internet website. This means that we will no longer send you forms that are available to be printed from the online source.

Exceptions are forms printed on secure paper. You will continue to order secure forms using forms HSMV 83416, Request for Division of Motor Vehicle/ Vessel Forms. You may find other forms that are not available online, which you will need to order from DMV as well. Those are the following:

80010 – Florida Motor Vehicle Dealer Licensing
82013 – Certificate of Destruction
82038 – Certificate of Repossession
82041 – Application for Title/Vessel or Registration
82497 – Notice of Discharge of Wrecker Operator Lien
82820 – Labels Return for Motor Vehicle Titles and Registrations
82994 – Motor Vehicle Dealer Title Reassignment Supplement
82995 – Motor Vehicle Dealer Power of Attorney/ Odometer Disclosure
